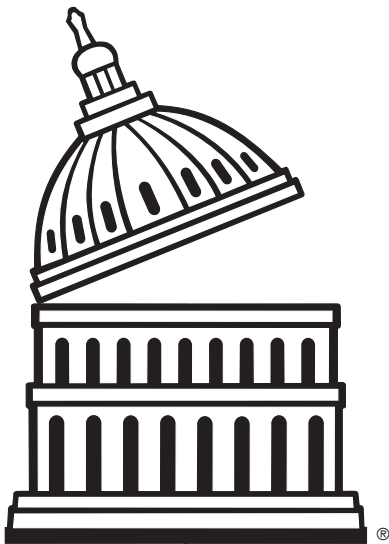

Published semiannually, the *Law Firms Yellow Book* provides in-depth coverage of the organizational structure of the largest U.S.-based law firms practicing general corporate law. The directory focuses on the management and administration of the firms, including committees, practice groups, and domestic and foreign offices. The current edition profiles 777 law firms with specific emphasis on the over 21,000 attorneys and administrative personnel responsible for management and decision making. It also includes biographical information, such as photographs, date of birth, education, outside affiliations, and career background for managing attorneys, as well as over 22,000 individual e-mail addresses.

The *Law Firms Yellow Book* lists U.S. law firms and their foreign offices. Its companion directory, the *Foreign Representatives in the U.S. Yellow Book*, covers the U.S. offices of non-U.S. law firms and includes U.S. representatives of leading non-U.S. companies and financial institutions, foreign governments, intergovernmental organizations, and non-U.S. media.

User's Guide

The firms in the *Law Firms Yellow Book* are listed in alphabetical order. Most of the listings in the directory will appear in the same format and contain most of the features as shown in the sample below. However, since our aim is to reflect the unique structure of each firm, some will differ in format and by the type of information included.

1 Each listing begins with firm name, address and communications information.

2 The **General Information** section may contain any of the following categories: (a) year founded; (b) number of attorneys (rounded) practicing at the firm, including counsel and of counsel, when this number is greater than 40; (c) any law firm network(s) to which the firm may belong; and (d) a brief practice description or list of practice areas when this information is not clear from the body of the listing.

3 The **Managing Partner/Head of Firm** section includes a photograph of the firm's managing attorney, his name, title, date of birth, education and career where applicable.

4 The **Management** section includes information on the members of the firm's major governing committees. Any of the following information may be listed for each individual (a) address, if different from the main address (b) telephone number and e-mail address (c) educational background (d) outside affiliation (e) career background. Executive assistants may also be included for managing attorneys.

5 The **Departments** section covers major areas of practice at the firm. In some cases, less formal practice groups are included in a separate list. Key individuals within each department are listed by title in the same format as the Management section. Departments are not listed for firms without formalized areas of practice or when departmental contacts are not available.

6 The **Administration** section lists the chief administrator of the firm first. The ensuing hierarchy is listed by title and for individuals with the same title, these are listed alphabetically. In general, we have listed the financial officer under the chief administrator and the librarian at the end of the listing. Administrators are listed with their direct-dial telephone numbers and e-mail addresses when available.

7 U.S. Offices, including top management and administrative personnel (when applicable), are listed alphabetically by state and within state by city. If the firm has foreign offices, these are listed by country and city according to the format used for U.S. offices.

If the firm has **Affiliates** or **Subsidiaries**, these follow at the end of the listing in alphabetical order and may be referenced through the Law Firms Index.
